SIDESHOW'S BIG BRIBE RULES

SIDESHOW'S BIG BRIBE CONTEST (THE "**CONTEST**") IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "**CONTEST RULES**").

- 1. **ELIGIBILITY.** To be eligible for this Contest, an individual must:
 - (a) be a legal resident of province of Ontario;
 - (b) be of the age of majority or older at the time of entry;
 - (c) live within fifty (50) kilometer radius of the City of Kington; and
 - (d) Nominees (defined below) of entrants must: i) be of the age of majority or older at the time of entry; (ii) be a legal resident of the province of Ontario; and (iii) have provided consent to enter the Contest.

Employees of Corus Radio Inc. operating CFMK-FM (the "Station") and its parents, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, the "Sponsors"), advertising and promotional agencies, and/or the household members of any of the above are not eligible to enter.

2. CONTEST PERIOD. The Contest begins at 8:00 a.m. Eastern Time ("ET") March 6, 2023 and ends at 7:00 a.m. ET on March 20, 2023 (the "Contest Period") after which time the Contest will be closed and no other entries shall be accepted.

3. HOW TO ENTER AND WIN.

- (a) There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
 - (i) To enter online, complete and submit the entry form located at <u>https://963bigfm.com/</u> (the "Contest Website") together with the name and phone number of five (5) friends (the "Nominees", each a "Nominee")

On March 20, 2023 at 8:00 a.m. in Kingston, Ontario, one (1) Nominee will be selected by a random draw from all eligible entries received during the Contest Period and announced on air. The selected Nominee will have nine (9) minutes to call in to the Station at (613) 544-9633 for a chance to win the prize. If the selected

Nominee is not able to call the Station within the allotted time, they will forfeit prize and another eligible Nominee may be selected in Contest Sponsors' sole discretion.

ENTRANTS WHO SUBMIT NOMINEES REPRESENT THAT THEY HAVE OBTAINED THE RIGHT TO USE THE NAME AND PHONE NUMBER OF THE NOMINEES IN CONNECTION WITH THE CONTEST AND FOR THE PURPOSES STATED HEREIN.

- (b) Limit of one (1) entry per household. A "household" is defined as any individual residing at the same address. In the case of multiple entries, only the first eligible entry will be considered.
- (c) All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- (d) Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. - (f) If the telephone connection between the Station announcer and a Nominee is not clear, such that the announcer and/or Nominee cannot hear each other or the Nominee is disconnected, that Nominee may, in the sole discretion of the Sponsors, be disqualified and the Releasees (defined below) will not be liable in any way.

4. PRIZE.

(a) **Prize.** There is one (1) prize (the "**Prize**") available to be won by the selected entrant and their five (5) Nominees (the "**Winners**", each a "**Winner**") consisting of:

(i) Five hundred Canadian dollars (CND\$500.00) for the selected entrant; and(ii) Fifty Canadian dollars (CDN\$50.00) for each of their selected Nominees.

- (b) The Prize has an approximate value of Seven Hundred and Fifty Canadian dollars (CDN \$750.00).
- (c) Winners are not entitled to monetary difference between actual Prize value and stated

approximate Prize value, if any.

5. PRIZE CONDITIONS.

The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if the Prize (or any portion thereof) cannot be awarded for any reason.

6. WINNER SELECTION.

- (a) The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors. If the selected entrant and Nominees does not respond accordingly, they will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including those reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest and/or Contest Website.
- 10. CONDUCT. All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited.
- **13. TERMINATION:** Sponsors reserve the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.
- 14. LAW. These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations. The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors.
